Delivery Policy

SAMPLE TENANCY AGREEMENT

- I have read the current standard tenancy agreement & room rate information and acknowledge that payment of the appropriate reservation fee enables me to reserve a room type.
- I understand that CityBlock will contact me, within 3 working days to continue the booking process.

Guarantor & Rent Payments

- If you choose to pay your rent termly, you will be asked to provide a UK guarantor for your tenancy.
- A guarantor is someone who guarantees the rent on your behalf (usually a family member).
- They will be liable for any payments that you cannot meet within the given deadlines.
- If you have a UK based guarantor you can pay either in termly instalments or annual in advance (with 3% discount)
- If you do not have a UK based guarantor, you will be required to pay the full rent in advance (with 3% discount)
- Your Guarantor will be required to sign your Tenancy Agreement and provide proof of ID

Cancellation & Refunds

- I understand that if, for any reason, I cancel within 7 days of submitting this online booking, I will receive the reservation fee back less any administration fee.
- I understand that if, for any reason, I cancel after 7 days of submitting this online booking, the reservation fee is non-refundable and will be retained by CityBlock to cover administrative and marketing costs.
